

Bisphenol A (BPA)



BPA has historically been used in a range of packaging and other applications. It has come under scrutiny in recent years and a study from the University of Granada has been reported in January 2019 by a range of media.

Current use of BPA by the Paper Industry

The use of BPA by the Paper Industry is extremely limited, only occurring in heat sensitive papers such as till receipts. Such papers are not made in the UK.

We cannot absolutely rule out the presence of BPA as a 'non-intentionally added substance' in recycled pulp but it remains unlikely and will be an extremely small (vanishingly so) amount in the grand total of all recycled paper. It should not be considered a risk.

Industry is phasing out BPA. In December 2016, the European Commission decided to restrict BPA in thermal paper in the EU. This ban will take effect in 2020, giving manufacturers, importers and users of thermal paper the time to phase it out and find an alternative.

Is BPA safe?

There have been many studies into the use of BPA, which have sometimes drawn contradictory conclusions. Importantly, two leading global authorities have commented as follows:

The European Food Safety Authority conducted a survey in 2015 which concludes that "BPA poses no health risk to consumers of any age group (including unborn children, infants and adolescents) at current exposure levels".

The Food and Drug Administration (FDA) in the USA has answered the specific question "Is BPA safe?" with a simple "Yes", going on to note that studies have shown "no effects of BPA from low-dose exposure"

CPI Position:

- It is unacceptable that politicians are allowed to overrule science when it comes to decisions on what is appropriate for food contact applications. Popular opinion is not a suitable basis for determining product safety. The principle of Mutual Recognition should be recognised. The French action is in contravention of this principle.
- Regulation (EC) 1935/2004 adequately sets the legislative framework for food contact in EU. Other voluntary initiatives, such as the *Industry Guideline for the Compliance of Paper & Board Materials and Articles for Food Contact* cover the requirements for paper and board.
- Paper and board has a long and successful history of safe use in the food industry in a wide range of applications. These include applications where intimate contact is involved, such as tea bags and baking papers, and direct contact packaging such as sugar bags and cartons for dry foods. It also has a range of uses in transport packaging.
- The sector has co-operated over a long period of time with government, both at national and European level, and with other regulators to ensure necessary levels of consumer protection.
